### SECTION 2: HAZARDS IDENTIFICATION

#### HAZARDS OVERVIEW:

A clear to slightly hazy, royal blue liquid having a very slight characteristic odor. The vapors, mists and liquid may cause severe irritation or burns to the eyes, and irritation to the skin and respiratory tract. It is toxic by ingestion and may be fatal if ingested in large quantities. Toxic to aquatic life due to copper sulfate content.

#### SECTION 4: FIRST AID MEASURES
