

INSTRUCTIONS

PREPARATION: Shake well before use. Can be applied in combination with compatible plant growth regulators, pesticides, or other liquid fertilizers. If compatibility is in question, jar test a small quantity. Do not apply this product in concentrations greater than 10% without a jar test.

APPLICATION: Designed for soil application to enhance beneficial microbial growth. This product supplies nutrients and/or biostimulants to soils and should be applied when soil analysis identifies the need and proper rate of application for this product. Best results will be obtained when application is concentrated in the active root zone. For field crops, apply post-harvest onto crop stubble, compost, or manure followed by shallow cultivation. For tree & vine crops, and for ornamentals, first application should be 15 to 20 days before planting, root flush or bud break, or at the onset of dormancy. For turf and sod, apply directly onto turf thatch or organic materials followed by light irrigation. Soil moisture is required for maximum bioactivity; if soil is dry. moisture should be provided by irrigation. Full label rates can be applied as often as every 15-20 days. as needed.

CONDITIONS: Application timing, intervals, and rates may vary according to individual soil types, available nutrient levels in the soil, and overall nutritional status of the plants.

STORAGE & DISPOSAL: Do not store this product below 50°F (10°C) or above 90°F (30°C). Keep product in original container. Do not transfer into food or drink containers. Triple rinse container when empty for recycling. Always dispose of container in accordance with local, state, and/or federal regulations.
