A liquid suspension (with an activator packet) of preselected and adapted anaerobes designed to improve biodegradation under anoxic and anaerobic conditions—such as sewer lines, primary treatment, anaerobic lagoons, and sludge handling/processing—to reduce hydrogen sulfide (H₂S) odors in conveyance and treatment systems. Developed for use in food processing, meat packing, and municipal sludge and waste treatment facilities.

- Improves biodegradation of solids and sludge in anaerobic conditions

APPLICATION:

Shake well before using. Contents are highly concentrated. Apply to the sewer line, primary treatment unit, or directly into the anaerobic lagoon wastewater flow. Dosing is dependent on both wastewater flow and concentration of hydrogen sulfide.
