PREPARATION: Shake well before use. Can be applied alone or with liquid fartilizers. If compatibility is in question, jar test a small quantity. Do not foliarly apply this product in concentrations greater than 10% without a preliminary foliar test.

APPLICATION: Designed for foliar and soil application. This product adds naturally occurring materials containing fulvic acids that may enhance plant nutrient availability and uptake. It should be applied when tissue and soil analysis identify the need and proper rate of application. Can be applied to all crops and turf. Best results will be obtained when application is concentrated in the active root zone or on the plant surface. Apply foliar sprays with sufficient water to ensure uniform coverage without running off leaf surfaces. Soil moisture is required for maximum bioactivity: if soil is dry, moisture should be provided by irrigation. Full label rates can be applied as often as every 15–30 days, as needed.

CONDITIONS: Do not apply nutrients during the hottest time of the day or to plants under drought or flood stress. Application timing, intervals, and rates may vary according to individual plant requirement, stage of development, available nutrient levels in the soil, and overall nutritional status of the plants.
