Best results will be obtained when application is concentrated in the active root zone or on the plant surface. Apply foliar sprays with sufficient water to ensure uniform coverage without running off leaf surfaces. For maximum results, apply early in the morning or in the evening when air temperatures are optimum for foliar application. Full label rates can be applied as often as every 7–10 days, as needed.
