

INSTRUCTIONS

PREPARATION: Shake well before use. This product supplies nitrogen to soil and should be applied when soil analysis identifies the need and proper application rate. Can be applied in combination with compatible plant growth regulators, pesticides, or other liquid nutrients. If compatibility is in question, jar test a small quantity. Do not foliarly apply this product in concentrations greater than 10% without a preliminary foliar test. Use caution when adding to high-analysis/multi-nutrient solutions, highly acidic or basic solutions, or unstable suspensions.

APPLICATION: Designed for soil and/or foliar application. This product supplies nutrients to plants and should be applied when tissue and soil analysis identifies the need and proper rate of application for this product. The best results will be obtained when application is concentrated in the active root zone or on the plant surface. Apply foliar sprays with sufficient water to ensure uniform coverage without running off leaf surfaces. For maximum results, apply early in the morning or in the evening when air temperatures are optimum for foliar application. Full label rates can be applied as often as every 7–10 days, as needed.

CONDITIONS: Do not apply nutrients during the hottest time of the day or to plants under drought or flood stress. Application timing, intervals, and rates may vary according to individual plant requirement, stage of development, available nutrient levels in the soil, and overall nutritional status of the plants.

STORAGE & DISPOSAL: Do not store this product below 50°F (10°C) or above 90°F (30°C). Keep product in original container. Do not transfer into food or drink containers.
