

INSTRUCTIONS

PREPARATION: Shake well before use. Can be applied in combination with compatible plant growth regulators, pesticides, or other liquid fertilizers. If compatibility is in question, jar test a small quantity. Do not apply this product in concentrations greater than 10% without a jar test.

APPLICATION: Designed for soil application where chemical toxicity may exist. This product supplies nutrients to soils and should be applied when soil analysis identifies the need and proper rate of application for this product. Can be applied to all soil types for agricultural fields, ornamentals, lawns, gardens, and landscapes. Best results will be obtained when application is concentrated in the active root zone. Apply directly to the soil with, or followed by, shallow irrigation. Soil moisture is required for maximum bioactivity: if soil is dry, moisture should be provided by irrigation. Full label rates can be applied as often as every 15–20 days, as needed.

CONDITIONS: Application timing, intervals, and rates may vary according to individual soil types, available nutrient levels in the soil, and overall nutritional status of the plants.

STORAGE & DISPOSAL: Do not store this product below 50°F (10°C) or above 90°F (30°C). Keep product in original container. Do not transfer into food or drink containers.
